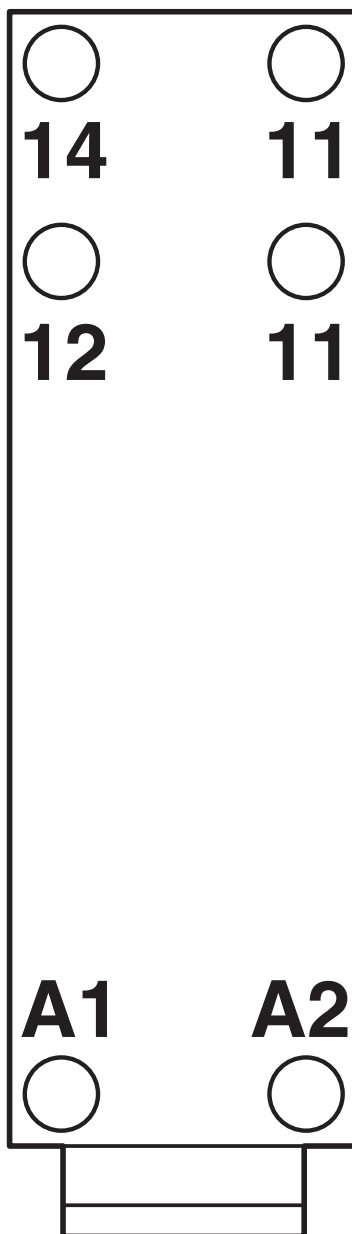

Connection diagram



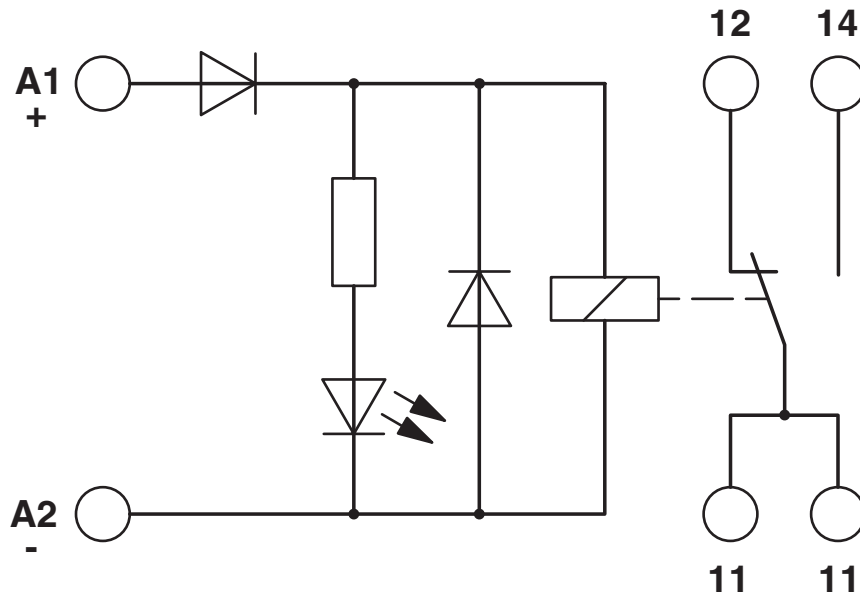
