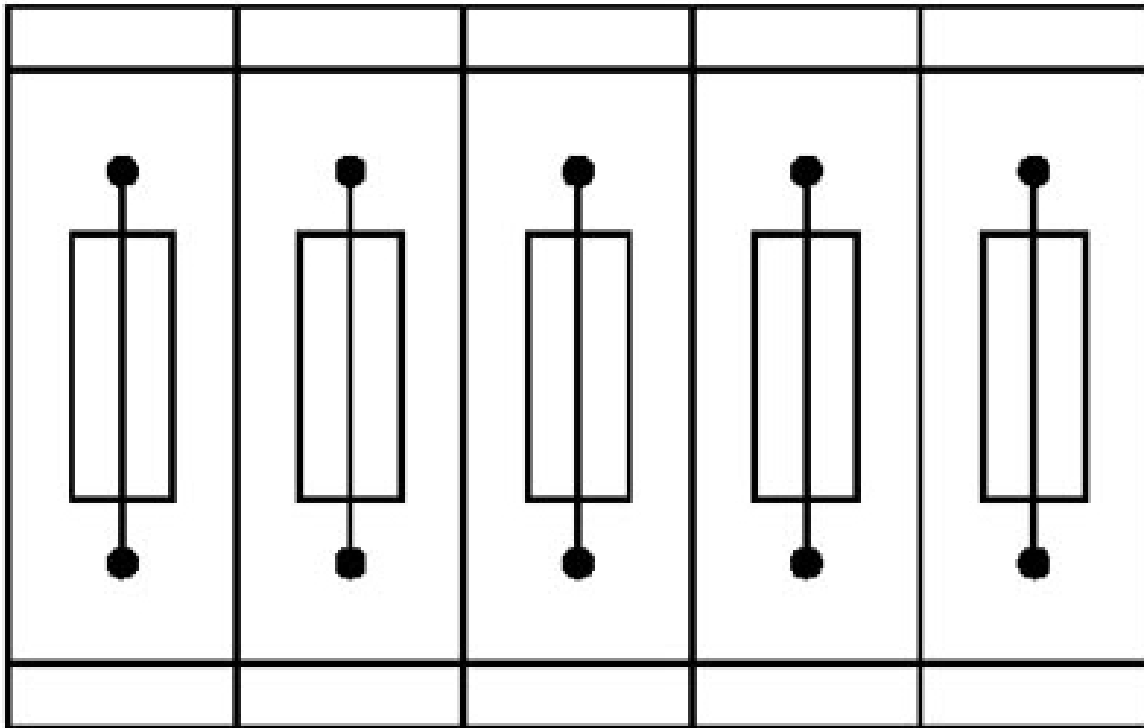

### Application drawing



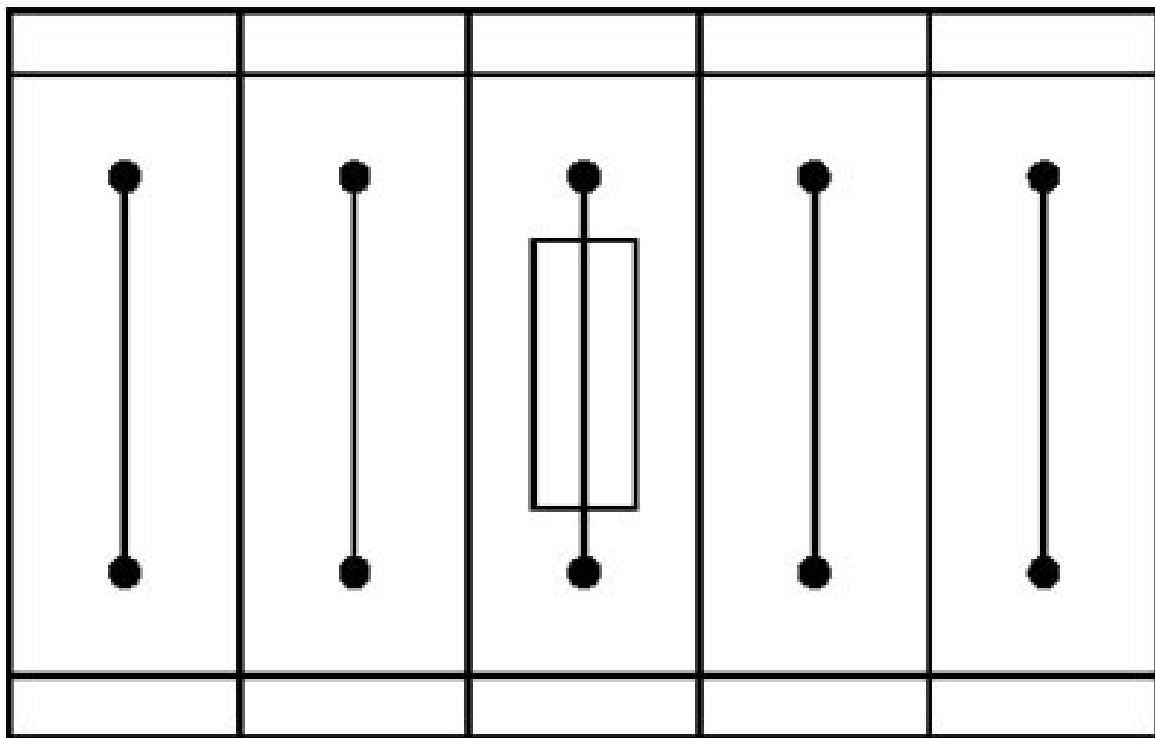
Fuse terminal blocks in interconnected arrangement,

Application drawing



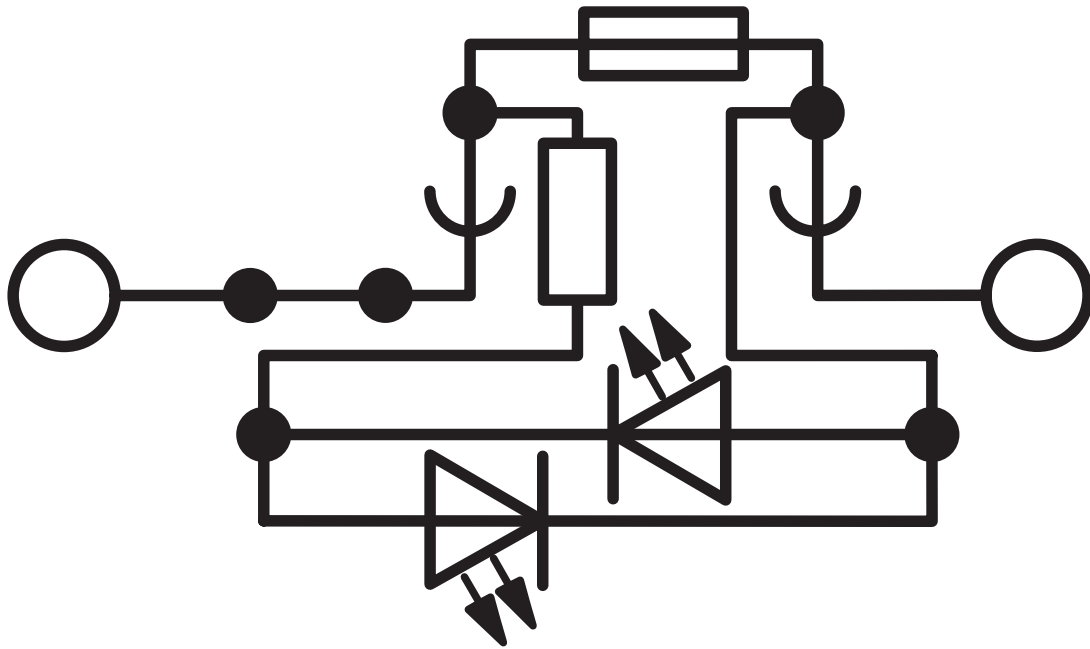
Fuse terminal block in single arrangement,
