Circuit diagram



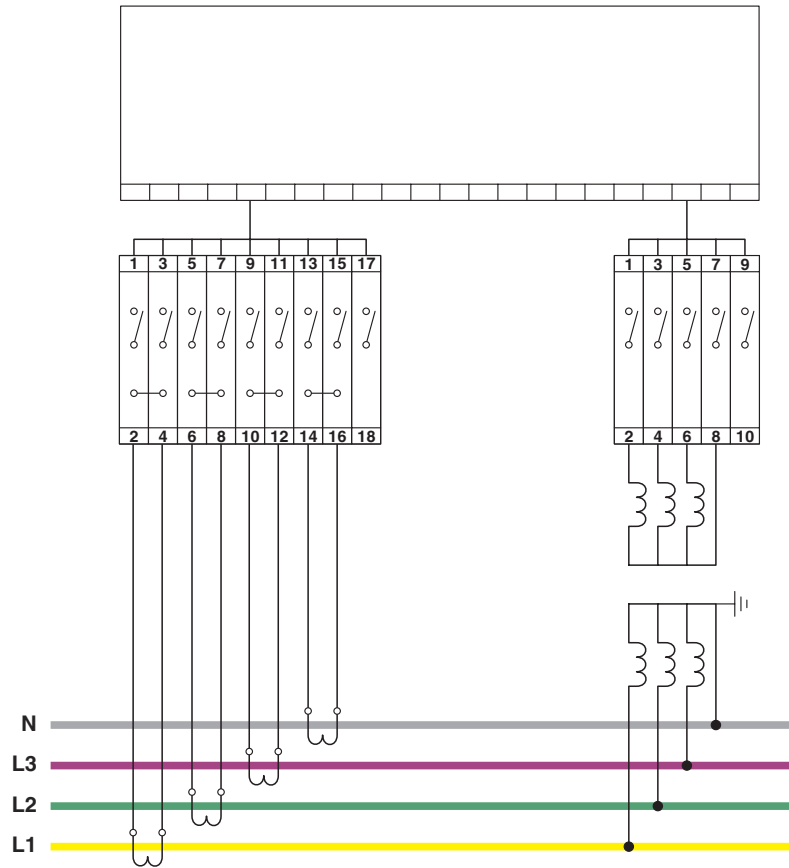
