Circuit diagram



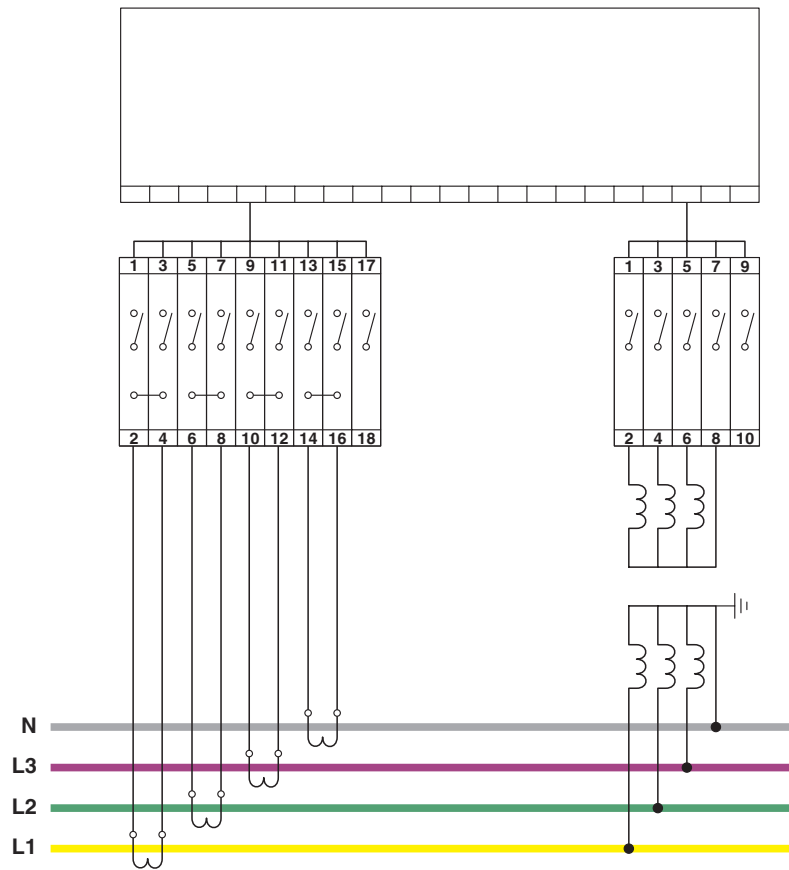
